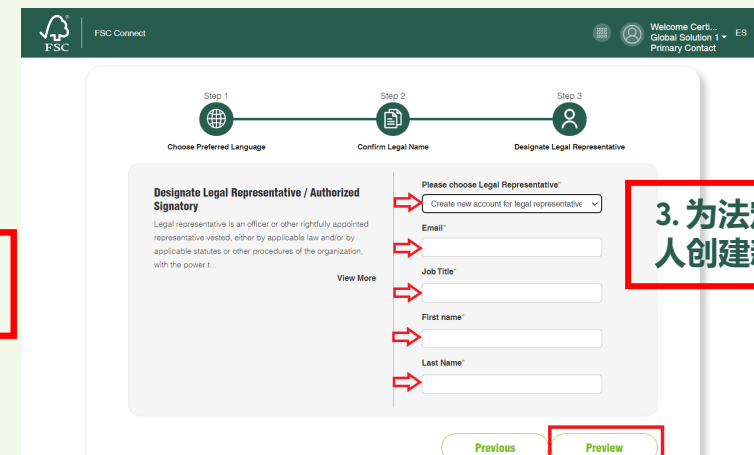
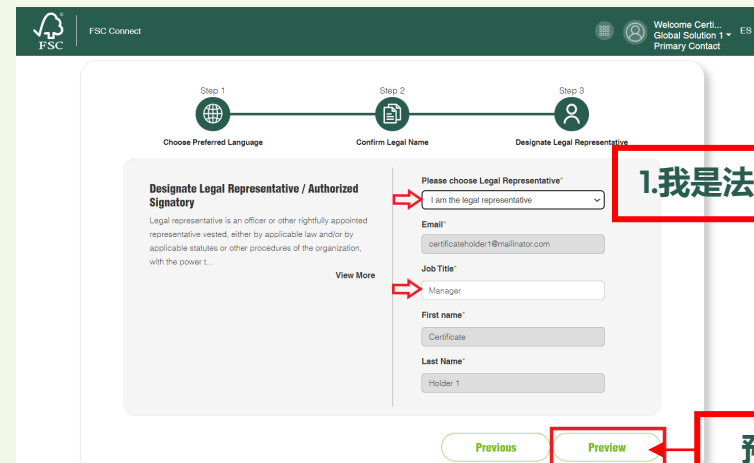
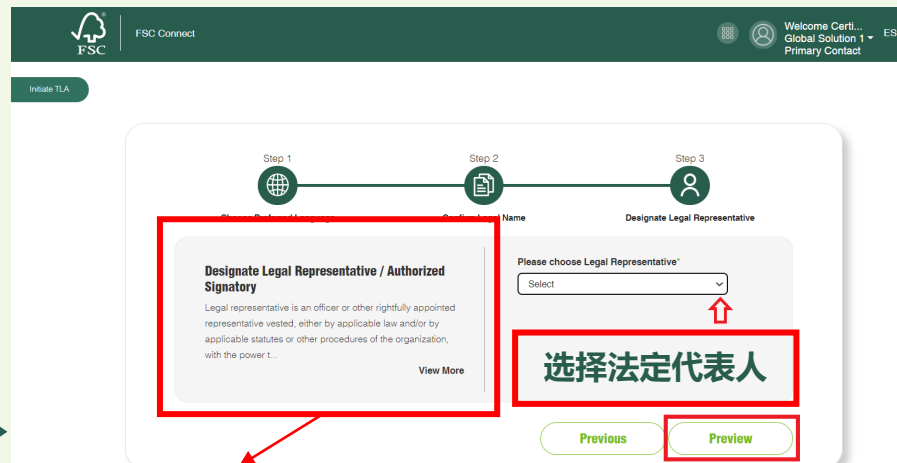

Instead of the invalid or unenforceable provision a valid and enforceable provision is deemed to have been agreed upon which most closely approximates the intent and economic effect of the invalid or unenforceable provision. The same applies in the case of an omission.

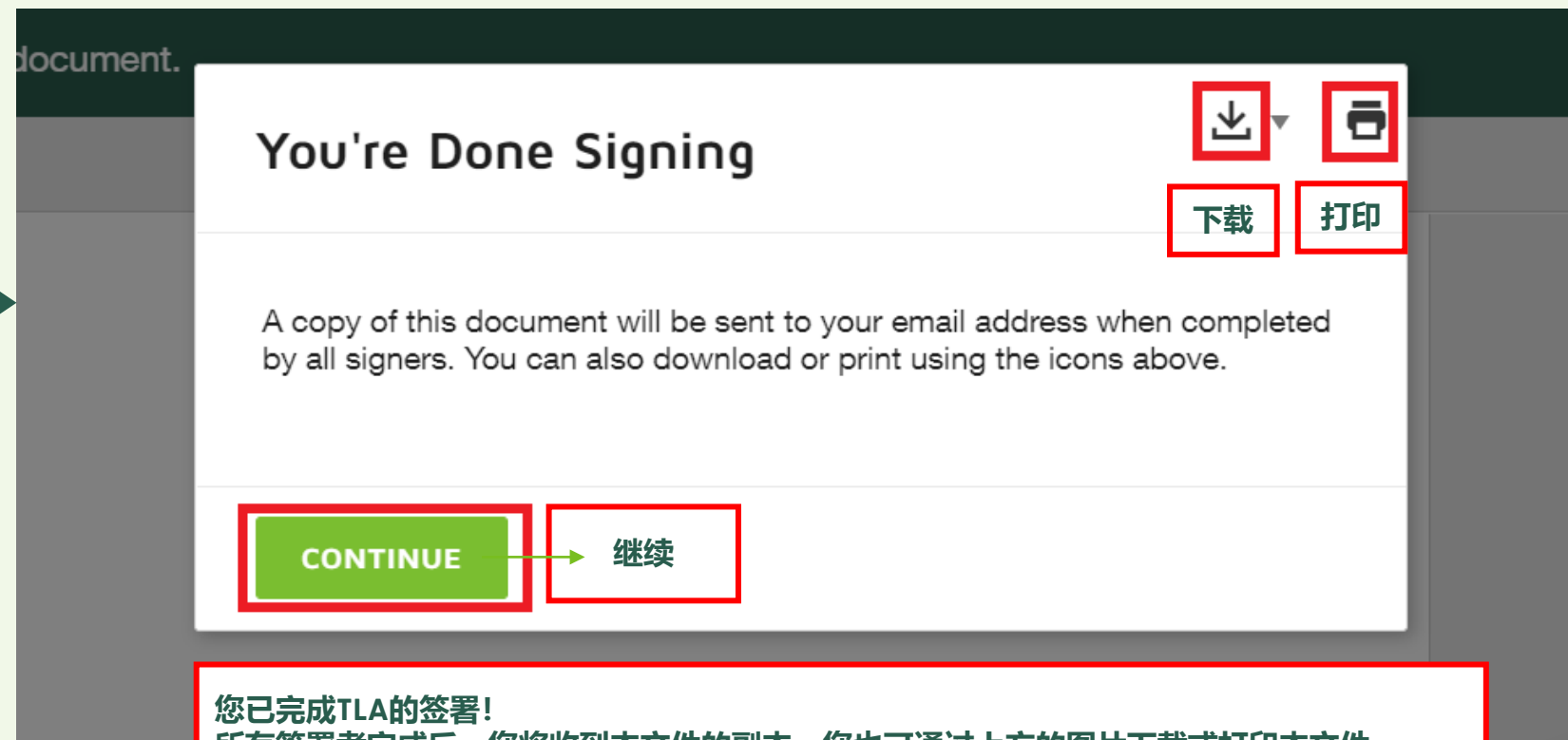
